## SAMPLE Camp Participation "Agreement"



### I. Welcome to the DREAM IT | DO IT Camp to Inspire Future Entrepreneurs

Your decision to participate in the **DREAM IT | DO IT Camp** ("Camp") illustrates a significant commitment to your aspirations as a future business leader, innovator or entrepreneur. To get the most out of the experience, and to enhance the experience for other participants, it is important that you engage at a high level during the Camp. The points that follow outline Camp highlights and expectations as we aim to ensure the effectiveness of the overall experience for each participant. The Camp is produced and hosted by the Umpqua Small Business Development Center (SBDC) and Umpqua Community College (UCC).

### II. Mission Statement

The Camp has a four-fold mission. Specifically, the Camp serves to:

1. **Foster Innovation.** Cultivate a creative environment that encourages curiosity, problem-solving, and innovative thinking among high school students, empowering them to explore new ideas and solutions.
2. **Inspire Entrepreneurial Mindsets.** Equip participants with foundational entrepreneurial skills, mindset, and tools necessary for identifying opportunities, taking calculated risks, and turning ideas into tangible ventures.
3. **Encourage Collaboration and Networking.** Facilitate a collaborative atmosphere where students can exchange ideas, work in teams, and build networks, fostering a supportive community that encourages learning from peers and mentors.
4. **Empower Future Leaders.** Empower young minds to embrace leadership qualities, resilience, and adaptability, enabling them to navigate challenges confidently and become catalysts for positive change in their communities and beyond.

### III. Camp Participation

All Camp participants are expected to actively participate in all Camp activities and complete assignments throughout the duration of the Camp.

The Camp is scheduled for Monday through Friday, **June 24–28, 2024**, 9:00 am– 4:00 pm, daily.

It is expected that Camp participants:

1. Be respectful of each other's time, including being prepared and ready to start Camp sessions on time;
2. Be respectful of different opinions;
3. Treat others with dignity and respect;
4. Refrain from disorderly or disruptive conduct;
5. Maintain the confidentiality of sensitive information shared by others;
6. Proactively communicate with Camp Director or instructors in advance of any absences for consideration of excusing the absence and/or to receive any relevant Camp materials or assignments;
7. Be actively engaged during Camp sessions, to include not being distracted by email, texts or phones. Use of cell phones or other personal computing devices is limited to designated daily break periods;
8. Use UCC computers, equipment, wi-fi and/or internet services in accordance with the UCC [Acceptable Use Policy](#).

#### IV. Program Cost and Cancellation Fee

1. The cost to produce and facilitate the Camp is significant, with planning and preparation starting many months in advance of the event.
2. The cost to participate in the Camp is waived thanks to generous funding from state and local sponsors.
3. Failure to cooperatively participate and/or complete the full five-day camp will result in a **\$150 Cancellation Fee** unless significant extenuating circumstances prohibit such completion. Breach of any element of this Agreement does not provide exemption from this fee.

#### V. Information Sharing

As a participant in the Camp and by signing this Agreement, you agree to allow the UCC and the SBDC to use your image and first name in current and future marketing materials, including on print and electronic media. The SBDC and the Family Education Rights and Privacy Act (FERPA) require this permission prior to the UCC or SBDC releasing this information.

UCC and SBDC staff maintain your personal information with utmost care and confidentiality, using supplied data only for aggregate reporting purposes, for enrollment in the Camp, and in case of emergency.

#### IV. Agreement
