

The Umpqua Community College Board of Education had a regular meeting on Wednesday, November 9, 2022, in room 17 of Tap'òyt'a' Hall at Umpqua Community College in Roseburg, Oregon; the meeting was live-streamed on YouTube. Board Chair Loosley called the meeting to order at 5:30 p.m. and the pledge of allegiance was given.

Changes to the Agenda: There were no changes.

INTRODUCTIONS

New Deans of Instruction were introduced: Scot Headley – transfer programs and general education; Joshua Ogle – Career and Technical Education; Danielle Haskett – Social, Health & Behavioral Sciences. New faculty were introduced: Tracy Redd – Math; Christina Ballard – Communications; Bart McHenry – Theatre Arts; Tanya Blacic – Geology; Austin Kennedy – EMS Program Accreditation Coordinator; Sheri Guerrero – EMS Program Director; Leesa Sterner – Nursing. Emily Adams is the Administrative Assistant to the Deans.

REPORTS

- **President's Report – Rachel Pokrandt, Ph.D.:** A written report is available online. An onboarding program was developed for the many new employees. UCC Success is an 8-week program and will be repeated in the spring. Enrollment numbers are up: Headcount is up 22% and FTE is up 7%; more students are taking fewer classes. For the second year in a row UCC's adult basic skills program lead the state in performance and skill. Upcoming and recent activities were highlighted: Sunday Tailgate, UCC Foundation Legacy Ball, Veteran's Day Parade, UCC play "39 Steps", and

Career Academy Open House. President Pokrandt now serves on a couple of boards: Southwestern Oregon Workforce Investment Board (SOWIB) and Umpqua Economic Development Partnership. The ACEN nursing accreditation visit will be in the fall of 2023, a full year ahead of schedule. Brand new digital signs have been installed at the front of campus and in athletics.

- **Healthcare program expansion plan – President Pokrandt:** As a result of conversation with medical providers, research on jobs that provide a family wage, and looking at education that is needed, UCC has created a healthcare program expansion plan. The College currently offers certificate programs for Community Health Worker, Medical Assistant, Basic Health Care, and Phlebotomy; these will now be credited and allow flexibility for future education. The Registered Nursing program will be offered in an alternative format over 3 years; OCNE approval is needed. The plan is to gradually implement the changes and programs, with accreditation and state approval, over the next three years. New programs are Surgical Technician, Licensed Practical Nurse, Respiratory Care, Radiology Technician, and Physical Therapy Assistant. The goal is to build a stackable pathway so the entry level programs will build upon each other for an eventual degree in healthcare.
- **Institutional Indicators – President Pokrandt & Steve Rogers:** Institutional indicators are a data-based tool designed to provide quantitative measurements of UCC's effectiveness in several specific areas of mission fulfillment and student success; their development began in May 2019. The indicator data is published to UCC's website annually. The scorecard, showing target levels for indicators, was reviewed. The data has been turned into action items such as a new governance structure, cementing the review of data into the governance structure moving forward, and action projects. The College will continue to look at the data and adjust accordingly. The Board would like to have an annual review of the data and key takeaways.
- **Financial Report – Natalya Brown, CFO:** The financial report for the first quarter ending Sept. 30, 2022, was presented. The beginning fund balance is preliminary data pending the auditor's final annual report. Overall, the College had a great start to the academic year which is reflected in the finance statements. Cash investments are in a good position and will carry the College through the state's fluctuation of payments. The entity wide statement shows a significant increase in grant funding activity. Appreciation was expressed to President Pokrandt and many staff for their grant efforts. The 3-month forecast is very comparable to last year; the forecast for the rest of year is a best guess. Overall, the College is on target with revenue and expenses. Property taxes are strong and expected to be received as budgeted. Tuition revenue was budgeted with a 1% increase; data is showing a 3.7% increase when compared to last year. The College anticipates a strong fiscal position.

NEW BUSINESS

A recently purchased housing facility needs to have a UCC approved name. As a part of the naming process, paragraph D of Board Policy 3650 Naming of Facilities and Other Entities was reviewed. Ideas were shared about gathering input on proposed names. A policy revision and name suggestions will be brought to the next meeting.

Board Comments

BOARD POLICY

TITLE: PUBLIC ART

BOARD POLICY # 3825

- A. Public art is visual art that is placed in an accessible location to be shared by the campus community and campus visitors. Umpqua Community College recognizes that the visual arts support the mission of the College by engaging students and the community in understanding and appreciating culture, aesthetics, and diversity. Campus public art may be:
1. Temporary, semi-permanent, or permanent
 2. Installed inside or outside
 3. Created by students, faculty, staff, or professional artists
- B. Art media may include drawing, painting, photography, printmaking, sculpture, ceramics, fiber arts, electronic and digital media, mixed media, or other.

All pieces of public art installed on campus must be based on the academic mission of the College and must promote appreciation of culture, aesthetics, and diversity. Public art installations are evaluated by a campus Public Art Committee (PAC) based on established criteria and requirements.



Alan King – Cross Country/Track & Field Coach, PE Faculty, Fit Center Manager

Coach King started his coaching career in 2004 in a high school in the remote village of Kasigluk, Alaska. In 2007, he started his college coaching career in Billings, MT at Rocky Mountain College where he built the new program into a top 25 nationally ranked team from 2011 to 2014. In 2014, Coach King moved to Canton, MO to take over as the helm of the track and cross country programs at Culver-Stockton College. Alan came to Umpqua Community College in the fall of 2018 to start building the Track and Field/Cross Country teams. Last year, the UCC track teams had their most successful campaign where the men finished 4th in the NWAC and the women finished 2nd, and Javelin athlete Zach Holland set the national Junior College record. Coach King has a M.A. in Kinesiology and holds USATF Level II certification endurance and also has USATFCCCA certifications in Strength and Conditioning, Track & Field Technical Coaching, and Track & Field Program Management.

Anthony Weerheim – Director of Wrestling


Mr. Weerheim started wrestling at the age of 4 years old and has been involved with the sport ever since. Having success with the sport in high school encouraged him to pursue a career at the college level. After graduating high school in Preston, Idaho he found his way to Oregon to continue his education and wrestling career at Clackamas Community College. During the time in Clackamas he met his beautiful wife Brittany, earned an AAOT and became an NJCAA All American. Next stop was Montana State University Northern where he earned a BA in Health and Physical Education and became an NAIA All American. Since then, he started his teaching career as an elementary P.E. teacher for a few years then transferred to the high school level where he was also the head wrestling coach for 6 years. This is his first year at UCC as the Director of Wrestling.


Dave Stricklin – Head Women's Basketball Coach

Mr. Stricklin came to UCC in 1994 after coaching for 8 years at Golden West College in California and has now coached one team (Women's Basketball) longer than anyone else in UCC history. The team has won 12 Region Championships, 2 NWAC Championships, has had 5 First Team All Americans, 8 Honorable Mention All Americans and for several years has been in the top ten in the country among all two-year schools in team grade point average. (Last year they were #1 in the country.) Most importantly the team has had well over 100 players receive basketball scholarships to attend and compete at four-year colleges and universities. Mr. Stricklin has been fortunate to coach four girls whose moms once played for him. He is married with four children and two grandchildren with another due to arrive in January. (Grandchild not child!) His youngest daughter Taylor is getting married on March 25.

Renate Richardson – Athletics Coach & Security Officer

Renate Richardson is from Newburg, Missouri and attended Culver-Stockton College ('18) where she received her Bachelor of Science in Legal Studies and Pre-Law, and she minored in Criminal Justice. At Culver-Stockton she ran Track & Field and Cross Country (under current UCC Head Coach, Alan King), and played basketball. Renate came to work at UCC in September 2018, where she helped Alan King start the Track & Field and Cross Country programs as an assistant coach. Renate primarily works with sprinters and hurdlers year-round, and distance runners in the Fall. Renate took over as Head Coach of the Obstacle Course Racing team in the Summer of 2020. She also competes in most obstacle course races with her athletes (most recently she won a Spartan Stadion event in San Francisco on December 3rd). Renate also worked briefly as the Interim Asst. Athletic Director from June 2019-December 2019 and has since continued small duties within the Athletic Department such as live game statistics, athletics website updates, driving teams to competitions, and trainings for the new coaches. In the Fall of 2022, Renate started assisting the Women's Volleyball team, and she started working as a part-time security officer, primarily working weekends and graveyard shifts. When Renate is not working with an athletics team, she spends her time with her 2 Dalmatians, Paisley and Pi.

<p>The Nursing Department is planning to make textbook and learning support materials easier for students to acquire and to build the cost of these materials into the program fee. By doing so, students will receive their books and associated digital learning materials in a streamlined process. Students will have all materials they need at the start of the term and the students will no longer need to purchase a \$1,655 (based on FY23 pricing) book bundle upfront.</p> <p>Rolling the book costs into the fee amount, will result in a fee change from \$375 to \$550 per term, while overall the fee change will reduce the cost of attendance by \$600 per student over the course of the program.</p>
