### Graduation Rates 200 Overview

Students graduate with the equivalent average of 8 terms of attendance regardless of the actual time it takes to complete the degree. The majority of our students attend part time as they have jobs, families, or life circumstances that prevent full time attendance. Consequently average time to graduation is greater than the 3 year federal measure. The average 2 year degree graduation rate hovers around 20%, not including certificates, with an additional 35% to 40% transferring on.
